

## Assurance Statement Chubb Fire & Security

Chubb Fire & Security B.V. (further referred to as Chubb Fire & Security) has commissioned FIRA Sustainability B.V. ### Scope

The scope for this assignment is: Security and fire protection services by Chubb Fire & Security B.V. (chamber of commerce 33257455) based in the Netherlands. Corporate (API Group inc.), and all its other (foreign) holdings and subsidiaries such as Chubb International B.V., Chubb Nederland B.V., and Security Monitoring Centrum B.V. are not in scope.

### CSR Report

Chubb Fire & Security expresses commitment to the principles of corporate social responsibility, and discloses its ambition on CSR issues as prioritized by the CSR-Register, including management approach, policies, measures and plans. An extensive issue analysis has also been executed.

### Methodology & Work Undertaken

Organizations process its sustainability information in the CSR-Register consistent with the ISO 26000 standard. FIRA verifies all claims and information in the CSR-Report based on moderate assurance. Claims and related information in the CSR-Report are reviewed based on the evidence made available by Chubb Fire & Security to FIRA to determine the plausibility of information. FIRA ensures that the assessment team possesses the required competencies and adheres to the principles of auditing regarding ethical conduct, professional integrity, and independence.

Programs are focused on health and safety, customer and employee satisfaction, human development, prevention of pollution, data security, carbon emission reduction and ethical behavior. We encourage Chubb Fire and Security to continue to expand practices with storytelling based on quantified impact and results. Furthermore, we encourage Chubb Fire & Security to disclose practices on circular economy and monitoring CSR risks in the supply chain.
- ① **Code of Conduct:** An ethical code of conduct is in place.
- ① **Commitment to CSR:** A CSR declaration, including commitment to all CSR principles and to progress on material issues, is in place. Through management statements commitment and ambitions are in place on environment, health and safety. We encourage Chubb Fire & Security to work on a declaration based on all material CSR issues.
- ① **Value Chain:** There is limited information on the origin of supplies beyond Chubb Fire & Security tier 1 suppliers (upstream). We encourage Chubb Fire & Security to collect additional supply chain data, especially for product related suppliers (components) and high risk items such as work wear.
